## Sybiz Employer Portal Sign Up Process

The following pages provide an overview of the Sybiz Employer Portal sign up process for Single Touch Payroll.

The process is fairly self-explanatory but some tips have been added and appear as follows: If mobile number only use this box

Note that bank details may be prompted for – this is not required, select 'Direct Credit' and leave all else blank.

You will need to repeat the registration process for each ABN.

You do not need to set up or import any employee information. Employee information will be transmitted via the STP reporting process in Sybiz Visipay 17.20 (released on or before 25 June 2018).

When ready you can start the sign up process to the Sybiz Employer Portal.




